### 2009 LAKE LEVEL MANAGEMENT

- Exact same targets and approach as 2008.
- As soon as we get a thaw and the water starts moving the pipe will be opened and 1 or 2 logs taken off weir to ensure that early water level is under control. Need to ensure that we do not move water from on top of ice (should that happen).

### FUND RAISING

It was the general consensus we need a project scoped to be able to pursue major funding. Money is however available for operation and maintenance of current system.

Projects we can consider fund raising for - these could be highlighted in grant applications. Ed and Larry volunteered to take a lead on fundraising/project definition.

- Annual operation of the weir/pipe hypolimnetic withdrawal system
- Annual education of property owners and recreational participants around the lake
- Potential - short term modifications to screen system to manage weed plugging issues in spring
- Longterm projects associated with upstream water management/treatment (discussed Guy Tremblay's and Pope's land)
- Protection of riparian areas around lake and upstream from lake - again Guy's land was discussed as an opportunity here

#### CLEAN LAKE DAY

Aug 15, 2009 at the Hub. Larry received email from Rick - do we want to book the same band as last year - yes - Larry will reply to Rick. Patti generously volunteered to Chair and will think thru whether a name change would be appropriate.

#### ALBERTA ENVIRONMENT

Rick got a call from Al Sosiak - do we want to continue water testing this year - Yes - Carol to follow up.

#### BOARD MEMBERSHIP

We will consider a modification to bylaws better describing the expectations for participation of board members. In the mean time existing board members that are currently not active with the committee with the committee will be contacted to hopefully draw them to the table.

The group chatted through the need to recognize past board members and recognize (when appropriate) volunteers that help the society. Larry will confirm the list of previous board members who are well deserving of a thankyou and Scott volunteered to work on a plaque that could be used for all.
